CONDITIONS OF HIRE

Huon Hoofbeats Inc. grants the hire of the grounds subject to the following conditions:

1. APPLICATION

The right to hire the ground is subject to Huon Hoofbeats Inc. receiving an application in the required form signed by the proposed hirer undertaking to comply with these conditions. If the proposed hirer is a club the application must include the personal undertaking by the president and secretary of the club.

2. HIRE FEES

Hire Fees shall be in accordance with the schedule of fees set by Huon Hoofbeats Inc.

3. INSURANCE

The hirer shall take out and keep current during the period of hire a liability insurance policy for a sum of not less than \$_____ insuring the hirer against all actions, costs, claims, charges, expenses and damages whatsoever arising out of or in relation to the hire.

Proof of the policy must be provided by way of a Certificate of Currency, which must be annexed to this agreement and form part of the agreement.

4. INDEMNITY

The hirer agrees to indemnify, and keep indemnified, and to hold harmless Huon Hoofbeats Inc. its servants and agents, and each of them from and against all actions, costs, charges, expenses and damages whatsoever which may be brought, or made or claimed against them, or any of them arising out of, or in relation to the hiring engagement.

5. GOOD ORDER

(a) The hirer shall be responsible for the full observance of these conditions and for the preservation of good order of the facility throughout the duration of the period of hire.

(b) No obscene or insulting language or disorderly behaviour or damage to property shall be permitted in any part of the grounds.

6. DAMAGES

The hirer shall accept full financial responsibility for damage to Huon Hoofbeats Inc. property except for normal wear and tear.

7. SUITABILITY

The hirer is to ensure that the grounds are safe and suitable for the event for which the ground is being hired.
